

CONTRACT THIS DOCUMENT IS NOT AN INSURANCE CERTIFICATE OR COVER NOTE

I the undersigned, hereby agree to hire from the Owner the motor vehicle described hereon for the period and charges stated. I will read the section below of this contract before driving the vehicle which shall be part of this contract.

I acknowledge receipt of the vehicle in sound roadworthy condition, complete in every respect, except for the particulars of damage described on the Vehicle Inspection Form and I undertake to return it in similar condition on completion of the period of hire.

I further undertake to return the vehicle to the Owner immediately should anything become defective, or the vehicle, wheels or tyres thereof sustain damage of any kind whilst in my custody.

I will not permit any other person to drive the vehicle.

I will not drive or permit the vehicle to be driven or parked on any beach, sands, or slipways.

I will not carry any number of passengers in the vehicle in excess of the number stated hereon.

I will check and maintain tyre pressures, engine oil and water levels in the above vehicle and I will make good any damage caused through neglect of this condition.

I understand that garaging the vehicle is my own responsibility.

In case of any accident to the vehicle I will take the names and addresses of all witnesses and will convey such information to the Owner immediately and further assist the Owner in so far as any legal or insurance claim is involved.

I agree not to admit liability for any damage to property or injury to persons caused whilst the vehicle is in my custody.

I will not permit any person to sit on the roof, **OR GENERALLY TO ABUSE THE VEHICLE IN ANY WAY, AND I AGREE TO PAY FOR ANY DAMAGE SO CAUSED, INCLUDING CIGARETTE BURNS, WHEELS, TYRES AND INTERIORS.**

I will not carry any passengers for hire or reward.

I absolve the Owner from all liability from any cause whatsoever and agree to return the vehicle not later than the date noted above. **AND IF VEHICLE IS NOT RETURNED BY THAT TIME AGREE THAT ANY SUMS DUE TO BE PAID BY ME AT TERMINATION OF HIRE.**

I understand that I am responsible for the safe custody of the vehicle whilst it is on hire to me and I undertake to exercise reasonable precautions for the security of the vehicle and will not leave the keys in the car whilst unattended.

I will not permit animals to be carried in the vehicle.

I certify that:—

(a) I have driven motor vehicles of this category regularly during the past twelve months as the holder of a full licence;

(b) I have not had any proposal or policy declined or cancelled or renewal refused or special terms imposed by any Insurance Company, Association or Underwriters;

(c) I have not been convicted of any offence concerning the driving of motor vehicles; other than stated above;

(d) I have not had my driving licence suspended at any time, within the last 5 years;

I certify that the above mentioned are the correct details of the accidents that I have had and the claims I have made within the past five years.

I declare that I have stated my age correctly and that I am the holder of a valid licence authorising me to drive vehicles of the same type as the vehicle specified in the schedule hereto.

I declare that all the particulars in this contract are true and correct and that no facts have been omitted, misrepresented, or any information withheld, with which the insurers of the vehicle should be acquainted.

I agree that this declaration shall also form the basis of the contract between the insurers of the Vehicle and myself although it is not to be read as an insurance certificate or cover note.

I agree that no refund will be allowed if this contract is broken by myself or for petrol unused, or if the vehicle becomes unusable for any reason not the Owner's direct responsibility.

I agree that if I am convicted of driving under the influence of drink or drugs then I will pay to the Owner the amount of any damage suffered by the vehicle whilst on hire to me, together with any loss of hire cost incurred.

NO PARKING ON YELLOW LINES, DAY OR NIGHT

(In case of unforeseen circumstances which do not allow Viceroy Hire Car to collect the vehicle at the exact time stated overleaf. All Hirers will make sure the vehicle is parked legally and safely for up to 1 hour after end of hire.)

YELLOW LINE

— ACROSS YOUR PATH MEANS 'STOP'

ONLY PROCEED WITH CAUTION WHEN YOU HAVE A CLEAR ROAD.

FILTER IN TURN

— ON ROUNDABOUTS AND JUNCTIONS WHERE MARKED.

TRAFFIC LIGHTS

— AMBER LIGHT MEANS STOP.

ACCIDENT

— STOP - DO NOT MOVE THE VEHICLE. TELEPHONE US AND THE POLICE IMMEDIATELY; FAILURE TO DO SO WILL INVALIDATE YOUR INSURANCE COVER AND MAKE YOU LIABLE TO POLICE PROSECUTION. POLICE TELEPHONE '999' NO COINS REQUIRED.

INSURANCE

— IS INVALID IF:—

1. YOU DRIVE OR PARK ON A BEACH, SANDS OR SLIPWAYS.
2. YOU LET ANOTHER PERSON DRIVE.
3. YOU DRIVE WHILST UNDER THE INFLUENCE OF DRINK/DRUGS.
4. YOU LEAVE THE KEYS IN THE CAR.

(Except on termination of the hire by agreement with the Company)

ADDRESS

— SHOULD YOU CHANGE YOUR JERSEY ADDRESS DURING YOUR STAY, PLEASE INFORM US IMMEDIATELY.

DAMAGE

— **ALL HIRERS ARE RESPONSIBLE FOR ANY DAMAGE TO WHEELS, TYRES OR INTERIORS.**

RETURNING YOUR CAR

— FAILURE TO RETURN YOUR VEHICLE AT THE TIME AND PLACE WILL ALSO RESULT IN A MINIMUM CHARGE OF £10.

ALWAYS LOCK YOUR CAR AND BOOT WHEN UNATTENDED
